Held indoors at **Canterbury Park in Shakopee.** This venue has four great halls with show space in which your car and others will be effectively arranged by our floor plan staff to show them off to their best advantage.

2 BIG DAYS! Saturday, April 12th and Sunday, April 13th, 2025. Set-Up will be on Friday only, April 11th, from 10:00 a.m. to 10:00 p.m with scheduled arrival times for entry.

Award program to begin Sunday at 5:00 p.m.

TOW MONEY will be paid at the rate of fifty cents (\$.50) per mile, with a maximum of \$200.00, to all accepted entries outside a radius of 100-miles, one way of Canterbury Park.

ALL ENTRIES MUST HAVE A DISPLAY. Club displays must be a recognized club or organization and have at least two accepted entries pre-entered to be eligible for Best Club Display.

A \$50.00 entry fee will be charged and must be received (and the \$35 elec fee if used) with your signed entry blank to be a completed entry.

All accepted show entries will have:

FREE PARKING, including trailers!

FREE - **rope post stanchions** (limited # available, 1st come first served.)

FREE - A Great Time !!!

All entry blanks must be postmarked by February 28th, 2025 for best consideration. Entrants will be notified by March 14^{th,} 2025 of acceptance. All entries must include at least two good photos of the car. Each accepted entry will be allowed two show passes. These passes will be good for the entire show. Additional passes may be purchased on set-up night only.

DON'T WAIT !! Due to our limited floor space, we suggest you mail in your entry immediately. Entries received after deadline are subject to stand-by status for space availability.

All entries will be roped off and under surveillance by G.S.T.A. officials and uniformed police during show hours, and Canterbury Park's Security after hours.

GSTA JUDGING: All entries in competition will be judged by 3 judges in each of 7 categories: **Paint, Chrome, Bodywork, Upholstery, Engineering, Engine, and Engine Conversion.** All entries qualify for the sweepstakes awards. Highest judge's points determine the winners.
